3. I willingly and voluntarily assume and accept all risks necessarily flowing from participating in the Event and agree to participate at my own risk.
4. 1. The Wandoan Show Society Inc reserves the right to reject any application at its' sole discretion and its' decision in this regard shall be final.
2. The final placement of stalls is at the sole discretion of the Show Society—YOUR PREFERRED SITE IS NOT GUARANTEED.
3. All Exhibitors and Itinerants, **must** contact the Space Steward before commencing to unload or set up.
4. Exhibitors shall not excavate, dig, or place pegs in their area without permission of the Space Steward.
5. The Wandoan Show Society reserves the right to have removed, any item it considers objectionable or dangerous which is offered to patrons for display, sale, or as a prize given or distributed.
6. All Exhibitors must comply with relevant Food hygiene, and Workplace, Health and Safety Regulations.
7. Exhibitors are responsible for supplying their own power leads, tables, chairs, display stands, and special lighting. ALL electrical equipment must have a current ELECTRICAL TEST TAG.
8. No vehicle is to move in the space area after 7am on operating days of the show without prior approval of the Space Steward. Itinerant car and van parking is available adjacent to the rear of the Willacy Pavilion.
9. **THE FOLLOWING ITEMS ARE NOT TO BE SOLD BY ITINERANTS: - Fairy Floss, Dagwood Dogs, Waffles, Doughnuts, Snow Cones, and Toffee Apples, as these are supplied by the Showmen's Guild.**
10. **BANNED ITEMS INCLUDE: - Drug related goods, explicit and hard-core T-Shirts, fake cigarettes, fireworks or crackers, fuel type firelighters, horns or trumpets, knives (including pen knives), Laser pointers, martial art Nunchakas, playing cards (nude or lurid), pressure pack 'Snow ', pressure pack "Fart" Gas, Silly String, Stink Bombs, Bouncing Beans, Shang-hi/Slingshots, Bomb Bags, Water Bombs.**

Fees:

To secure a site, Payment must be submitted within 14 days from invoicing.

Space will not be allocated unless a completed application form has been submitted and approved.

On approval of your application, a tax invoice will be forwarded to you for payment:

Your site will not be guaranteed until full payment has been received.

Early cancellations will be refunded, less a 10% administration fee. Any cancellations received less than 10 days prior to the show will not be refunded, unless the site is able to be filled.

Entry to Show:

ONE only "2-day pass" is included in the cost of Itinerants site space.

Two only "2-day passes" are included in the cost of Machinery/Resources site space.

Passes are required for entry to the grounds after 7am on all show days.

Extra "2-day passes" are available at \$15 each for Itinerants or Machinery/Resources Exhibitors.

Display and/or Sale of Goods:

Applicants are to clearly state **ALL** types of goods that they wish to display and/or sell, attach an additional list if needed.

The Wandoan Show Society reserves to right to have items removed from sale.

Setting Up:

NOTE FRIDAY 5th APRIL Is A PUBLIC HOLIDAY for Wandoan.

Entry to all sites will be available from 9am, on the day prior to the Show. For earlier arrivals please contact the Space Steward.

All Exhibitors and Itinerants with large caravan displays and outside stalls must be on the grounds by 1pm on the day before the show commences, to facilitate positioning on your allocated site.

Smaller stalls are required to be in position before 8am on the first day of the show, to reduce the risk to the public.
